Items for discussion:

- 1. Review minutes.
- 2. Mission Statement. Review towns and cities HRC mission statements. What is the intent and purpose of the committee? Essential mandates of an HRC are: would provide advocacy for protecting the rights of all town residents by promoting equity and inclusion, sharing resources, providing education and guidance, addressing discrimination and racism and celebrating diversity. How would an HRC promote an inclusive welcoming culture in Deerfield?
- 3. Discuss the options for the town on Human Rights. Given Deerfield's size and resources what kind of organizational structure makes sense? (Human Rights Committee, Commission,

Task Force or Advisory Board? Could we recommend starting out as a committee like No Place for Hate, or a Human Rights Advisory Committee? Hull has a NPFH town of 10,000.)

- 4. What is your position on town employees serving on the HRC? Pros and cons? Since this is the Selectboard's appointment, what is the current policy for the Town of Deerfield?
- 5. HRC members and recruitment. How do you recommend the town recruit members for the committee? What kind of outreach do you recommend to reach diverse members of our community? (Diversity including; people of color, people of all religions, cultures, age, ancestry, genders, gender identity, sexual orientation and physical abilities.)
- 6. Form recommendations sub-committee to begin writing up findings and recommendations.
- 7. Schedule next meeting. Two more meetings. Scheduled SB appearance on 3/22.
