Pursuant to a notice duly filed with the Town Clerk, a meeting of the Deerfield Selectboard/Board of Health/Sewer Commissioners was held on January 7, 2025 at 6:00 pm at the Deerfield Municipal offices, Main Meeting Room, 8 Conway Street, South Deerfield, MA, Meeting was recorded by FCAT and/or Town of Deerfield Staff. This meeting was held in a **Hybrid** fashion for both in person and remote participation in accordance with House Bill Number 58 of the 193rd General Court, which extended the Governor's March 12, 2020, Order Suspending Certain Provisions of the Open Meeting Law, M.G.L. c.30A § 20, until June 30, 2027. In accordance with M.G.L. c.30A, anyone intending to record the meeting must identify themselves to the clerk and provide their name and address for the record.

 - i. The Board and Comerford highlighted the need to review the Foundation Budget Review Commission, which was established over a decade ago, and emphasized the importance of considering declining enrollment, rural schools, and special education funding in the review. They also discussed the target local contribution and the impact of wealth on municipal budgets, noting that Deerfield's larger size helps mitigate the impact of wealthy individuals. The conversation ended with a brief mention of the rural school bill, which has been reported favorably by the Ways and Means committee in the Senate.
 - ii. East West Rail, Micro Transit Initiatives, Housing, Water Resources, Elm Street & Park Street MassDOT Collaboration, General Fiscal Concerns, Health Care Challenges, Municipal Empowerment Act, and Further Representation on State Boards for Western Massachusetts Communities were additional topics covered.

Motion the Selectboard Pursuant to the vote taken on Article 6 of the Special Town Meeting held on October 29, 2025, establish permanent protection of land located on Steam Mill Road, Deerfield, Massachusetts and as shown on the Town of Deerfield Assessor's Map 79, Lot 39, including 31 acres, more or less, whose deed is recorded at Book 731, Page 32 of the Franklin County Registry of Deeds, for the exclusive purpose of conservation as Town Forest in accordance with Article 97 of the Amendments to the Constitution of the Commonwealth of Massachusetts; and further move that the Selectboard enter into and negotiate all necessary and related documents, subject to such restrictions and limitations as the Selectboard deems appropriate, in order to effectuate the permanent protection of said parcel accordingly – McDaniel
