Pursuant to a notice duly filed with the Town Clerk, a meeting of the Deerfield Selectboard/Board of Health/Sewer Commissioners was held on January 21, 2025 at 6:00 pm at the Deerfield Municipal offices, Main Meeting Room, 8 Conway Street, South Deerfield, MA. Meeting was recorded by FCAT and/or Town of Deerfield Staff. This meeting was held in a **Hybrid** fashion for both in person and remote participation in accordance with House Bill Number 58 of the 193rd General Court, which extended the Governor's March 12, 2020, Order Suspending Certain Provisions of the Open Meeting Law, M.G.L. c.30A § 20, until June 30, 2027. In accordance with M.G.L. c.30A, anyone intending to record the meeting must identify themselves to the clerk and provide their name and address for the record.

Ma Swedlund, Sugarloaf Condominiums: Expressed concern for the large increase in property taxes and request the Board to consider abatement opportunities for Seniors & Veterans.

 - a) Joshua Sparks, EMS Chief Regarding Position Goals and Objectives for Fiscal Year 2027
 - i. The Board and Sparks reviewed goals and objectives for the period between March 2026-2027, which include clinical excellence, workplace safety, quality, fiscal management, human resources, monthly reporting, and intermunicipal agreement review. Sparks discussed his excitement about the Community EMS project and establishing a capital fund to ensure sustainability. The Board also approved a new ambulance with a rebranded design, which Joshua visited in Syracuse, New York, and plans to debut in the coming weeks.

- b) Fats, Oils, and Grease (FOG) Regulations for Sanitary Sewer Hearing
McDaniel Read the Hearing Notice into the Record.
 - i. Dunne, Saviski, and the Board briefly discussed FOG Regulations proposed to support the Wastewater Treatment Plant operation. Ensuring reduction/elimination of any items not permitted to flow into the system.

ii. Statement of Purpose:

“The Purpose of these Regulations are to Protect Residents, Businesses, and the Environment within the Town of Deerfield from blockages of the Town Sanitary Sewer System The purpose of this Regulation is to protect residents, businesses and the environment within the Town of Deerfield from blockages of the Town’s sanitary sewer system caused by Fats, Oils, and Grease (FOG) discharged from Food Service Establishments. All new and existing facilities that generate and discharge FOG in the wastewater flow of the Town’s sanitary sewer system shall install, operate, and maintain a FOG pretreatment system, as further defined herein. The requirements of this Regulation shall supplement, and be in addition to, the requirements of the Town of Deerfield Sewer Use Regulations, Massachusetts State Plumbing Code and the Massachusetts State Sanitary Code.”
