Meetings normally held at the Municipal Offices are being held in **Hybrid** fashion, with adequate, alternative means of public access, and where required, public participation provided, in accordance with the Governor Baker's June 16, 2021 Act Extending Certain COVID-19 Measures Adopted During the State of Emergency, including an extension of the remote participation provisions of his March 20,2020 Executive Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A §20.
